

**NEW YORK LABOR LAW SECTION 195.1 (WAGE THEFT PREVENTION ACT) ADDENDUM  
TO SCREEN ACTORS GUILD EMPLOYMENT CONTRACT FOR TELEVISION COMMERCIALS**

**Beginning April 9, 2011, NY State requires that ALL employees be given notice of their rate of pay, wage status and pay day at time of hire.**

Your rate of pay is disclosed in the chart below as determined based upon the selections made on page one of Exhibit A-1 Standard SAG Employment Contract for Television Commercials. Should additional responsibilities / time be added to your employment during the shoot, it will be at the contractual rates set forth below:
